

The President introduced Jason Jackson (the Mayor of El Centro) who spoke to us about two tax initiatives that are on the ballot this November. One involves a 1/2 cent sales tax increase and the second adds 3% to the current 10% room tax in motels. Mayor Jackson spoke about the need for additional funding to deal with the new library, the new police department, the need for additional parks (multi-field





sports complex and a dog park) and other facilities to enhance our community, etc.

The discussion then turned to the bonding of a percentage of the sales tax to be able to build the facilities immediately.
