
Whining and Fining

City of Imperial Planning and Development Director

Chris Moore introduced the speaker George (Jorge) Galvan. Mr. Galvan is Planning and Development Director for the City of Imperial.

He spoke about "UP", "DOWN" and "ALL AROUND" in the City of Imperial.

The City of Imperial consists of an area of six and one-half square miles (in the city limits), has a population as of February 1, 2017 of approximately 18,000 souls, is projected to grow at a clip of 9.5% in the near future and has an average family income of \$57,152.

Mr. Galvan spoke about "Worthington Square" (a mixed-use property) with residential abodes above and commercial business below. The city hosted the Worthington Square grand opening last November 18, 2016.

The city population expends about \$14,000,000 a year for food. The city currently is home to Alford Distributing, Claypool Distributing, Pentagonal Brewing Company and plans to have the Humble Farmer Brewing Company.

Their most famous Motel (which still needs some infrastructure that is 3 months out to bid and 9 months out to construction) is currently planned to be a Ramada Inn. Only 12 years in the planning and construction stage, we hope that the project is completed

soon. In addition, Mr. Galvan spoke about Imperial's Regional Park & Equestrian Center, the Library, Transit Park, Sculpture Garden, etc.

We are very pleased to see the planning and growth in Imperial and need to get Mr. Galvan back to talk to us again. Thank you Chris for a very good program!

The Four Way Test of the things we think, say or do guides Rotarians.

The test is as follows:

- 1. Is it the TRUTH?
- 2. Is it FAIR to all concerned?
- 3. Does it promote GOOD WILL and BETTER FRIENDSHIP?
- 4. Will it be BENEFICIAL to all concerned?

The Rotary Board, at their last meeting, approved the following clarifications to the Membership Proposal Process. The reasons for the changes are listed at the bottom of the page.

(REVISED) MEMBERSHIP PROPOSAL PROCESS

- 1. Prospective Members may only be proposed for Membership after attending, as a guest, at least three regular meetings. After which, if Prospective Member is interested in joining, Sponsoring Rotarian proposes them for membership by submitting a completed Membership Proposal Form to the Club Secretary. The proposal is kept confidential during the preliminary phase.
- 2. Upon receipt of a Membership Proposal Form, the Classification Committee shall determine the eligibility as to classification; and the Membership Proposal Review Committee shall investigate the character, business, and general eligibility of the Prospective Member. Once eligibility is determined, the appropriate recommendation is made to the Board.
- 3. Based on the recommendation, the Board shall vote to either approve or disapprove the Prospective Member within 30 days of being proposed for membership.
- 4. With a favorable decision by the Board, the Rotary Information/Education Committee shall, with assistance from the Sponsoring Rotarian, inform the Prospective Member of the purposes, privileges, and responsibilities of membership, including attendance requirements and financial obligations. The Prospective Member and Sponsoring Rotarian shall each sign the Statement of Intent Form. And the Prospective Member signs the Membership Proposal Form giving permission to the club to publish his/her name and proposed classification. And, upon receipt, the Club Secretary publishes the Prospective Member's name for two consecutive weeks in the Club Bulletin.
- 5. If no member files a written objection within seven days after the second publication, the Prospective Member is considered to be elected to membership. The Club Secretary notifies the Sponsoring Rotarian of membership approval. The sponsoring Rotarian then notifies the new member.
- 6. If an objection is filed by a member of the club, the Board will meet and consider the Prospective Member. The board shall vote on this matter at its next meeting. If approved by a two-thirds vote despite the objection, the Proposed Member, upon payment of the admission fee (if not honorary membership), shall be considered to be elected to membership.
